OFFICER M. GOODMAN: On 06-02-11 at 1637 hrs. [REDACTED] at [REDACTED] Bannock reported that a black male who had been selling cleaning supplies door to door had forced her to give him oral sex and then intercourse.

A male, Hakeem Thomas, was found in the area and had clothes that matched the suspects description.

[REDACTED] identified the clothing as belonging to the suspect.

Thomas was arrested and interviewed by Detective Stiffler during which Thomas admitted to the sexual acts but claimed it was consensual.

[REDACTED] and Thomas were both transported to EIRMC where sexual assault kits were completed.

Thomas was booked into the Bonneville County Jail on a charge of rape.

DETAILS: On 06-02-11 at 1637 hrs. I contacted [REDACTED] outside [REDACTED] Bannock. [REDACTED] told me that his friend, [REDACTED], had called him and stated that a door to door salesman had forced her to "suck his dick".

I contacted [REDACTED] inside the residence, [REDACTED] Bannock, which was her house.

[REDACTED] told me that a black male, tall and thin, had come to the door selling cleaning supplies.

[REDACTED] said that she let him in and he demonstrated the cleaner on the living room carpet and then on the kitchen stove.

[REDACTED] stated they went back into the living room and when she sat down the male pulled down his pants, grabbed her by the back of the head and forced his penis in her mouth.

[REDACTED] said she was scared to do anything and was unclear but said at some point the male put on a condom and had intercourse with her "in the butt".

[REDACTED] told me that the male gave her some tissues to wipe herself with, which were in a basket next to the recliner in the living room, and had then left.

[REDACTED] described the black male as tall and thin wearing a gray jacket, light brown pants, blue shirt, black and purple tie and white shorts with red on them. The male had been carrying a black backpack and had an ipod. [REDACTED] said that neighbors told her the males name was Hakeem.

Notes/Narratives

I broadcast the description to other units arriving in the area to assist. I contacted Sgt. Hall who contacted Detectives who responded to the scene.

Officers in the 900 block of Ada, including Officer Ockerman, reported they had several black males detained. Officer Ockerman reported that he had located a possible suspect.

I drove [REDACTED] to the 900 block of Ada where the males were detained. At first [REDACTED] could not pick out her attacker but when Officer Ockerman showed her a shirt, pants, ipod and backpack [REDACTED] identified them as the clothes etc the male had been wearing.

Officer Ockerman told me that a van had pulled up when they were talking to a black male. The van belonged to International Sales and was dropping off subjects who were selling cleaner.

In the back of the van he had located a black male who was wearing only a white t shirt, white shorts with a red stripe on the side, socks and sneakers. The male had identified himself as James Bryant but Officer Ockerman discovered his real name was Hakeem Thomas. (See Officer Ockerman's report for details).

All the other subjects selling the cleaner were dressed in shirts and ties so Thomas stood out.

Due to all the facts I advised Thomas that he was under arrest, handcuffed him and placed him in Officer Ockerman's vehicle.

I then transported [REDACTED] to EIRMC where I was met by forensic nurse Tara Demkowicz and Detective McDonald.

I returned to the station and contacted Detective Stiffler who had finished interviewing Thomas. Detective Stiffler had me transport Thomas to EIRMC for a sexual assault exam.

At EIRMC nurse Demkowicz finished her exam of [REDACTED] and turned the evidence over to me. She then conducted an exam of Thomas.

I transported Thomas to the Bonneville County Jail where he was booked in on a charge of Rape 18-6101.

I then returned to EIRMC, picked up the last of the evidence and transported it back to the station. At the station the evidence was turned over to Detective Stiffler in the lab.

On 06-02-11 at about 1640 hrs, I stopped in the 900 block of Ada to assist Officer Hart who identifying a male concerning a Sexual Assault call in the area. While speaking with the subject, a silver full size Ford van (California plates 6JYJ004 registered to International Sales) pulled up next to us. Maurice Davis got out of the van and contacted me. He advised that he was in charge of the sales group that was in the area selling cleaning supplies and wanted to know why we were talking with one of his employees. I advised him that there had been a report of a crime in the area and we were checking his employee's identification. I asked Maurice Davis how many employees he had in the van with him. He stated that there were 4 or 5 other subjects in the van and gave consent for me to contact them. I looked in the van through the window and found three black males: the driver and two others sitting on the middle seats. None of them matched the clothing description of the suspect.

I continued speaking with Maurice Davis for a few minutes until I noticed movement in the back seat of the van, where I had not seen anyone sitting when I looked the first time. Maurice Davis again gave consent for me to look in the van. I then found a black male sitting in the rear seat. He was wearing a white t-shirt and shorts. The other subjects were all wearing pants, dress shirts and ties. I asked the subject why he had been hiding, but he stated that he had been sitting there the whole time. At my request, he exited the van. He stated that he had no identification and stated that his name was "James Bryant" with no middle name and a date of birth of 03-08-93. When asked how to spell his last name, he had to think for several seconds before spelling it. When asked what his social security number was, he stated that it started with "60", but could not remember the rest.

Because of the subjects behavior, I contacted Officer Goodman, the Responding Officer, and advised him of what I had found. He advised that he would bring the victim to our location. Other Officers arrived on scene as I continued speaking with Maurice Davis. He advised that the van belonged to the company and that he was in charge of it. He gave me consent to look through the van. On the floor in front of the back seat where the male was sitting, I saw a black backpack with red trim. I asked the subjects from the van who owned the backpack. The male that had been sitting on the back seat stated that it was his. I asked him if I could search it and he stated that I could. Inside I found a multi color button up shirt that had an International Sales Identification badge for Hakeem Thomas on it. Officer Goodman had advised earlier that the suspect's first name was possibly "Hakeem". The picture on the identification matched the subject who had identified himself as "James Bryant". There was also a gray sweat shirt inside the back pack and an "ipod". Both of these items also matched the description of the suspect. I asked the male if the items in the backpack belonged to him, and he stated that they did. I then advised the subject identified as Hakeem Thomas that he was being detained for further investigation and handcuffed him. I looked in the van again and found a purple and black tie on the back seat and a pair of tan pants stuffed under the seat behind a coat where Hakeem Thomas had been sitting. Hakeem Thomas advised that the pants were his.

Officer Goodman arrived on scene with the victim, [REDACTED] I collected the tan pants, the gray sweat shirt, the multi color dress shirt, the purple/black tie, the "ipod" and the backpack and began walking toward Officer Goodman's vehicle where [REDACTED] was sitting. [REDACTED] immediately pointed at each of the items identifying them each, stating that they belonged to the suspect.

I took custody of all of the items and later turned them over to Det. Stiffler at the LEB.

I spoke with Maurice Davis again. He stated that he had picked up Hakeem Thomas on Bannock at Anderson. He then advised that while they

drove looking for other employees, Hakeem Thomas began changing his clothes, but he did not know why.

Hakeem Thomas was advised by Officer Goodman that he was under arrest. I then transported him to the LEB where he was turned over to Det. Stiffler. I had dispatch run a check on Hakeem Thomas out of California. They advised that they only found an Index Number for him of X8157486 and no Criminal History. No further action taken by this Officer. end sbo

Summary:

Detective Lincoln McDonald's reported regarding the sexual assault that occurred on 06-02-11 at [REDACTED] Bannock Avenue. Details of the interview of victim [REDACTED]

Report:

On 06-02-11 at around 1630 hours, I was informed of a sexual assault that occurred in the 900 block of Bannock Avenue. Radio traffic indicated that the suspect was still in the area and that officers were searching for him. I traveled to the area and began assisting in the search for the suspect. Before arriving in the area, information was given that a possible suspect had been located by officers on Ada Avenue, which is one block east of Bannock. I arrived in the area and began assisting.

The victim, [REDACTED] was brought to the area by Officer M. Goodman, and identified Hakeem Z. Thomas as the perpetrator. I was asked to meet [REDACTED] at EIRMC to conduct an interview regarding the incident. [REDACTED] was transported to EIRMC by Officer Goodman. Once I arrived at the hospital, I was directed to the women's center and met with [REDACTED] who was already in an examination room. In the room with us during the interview was [REDACTED] mother, [REDACTED]

[REDACTED] advised that earlier this date, door-to-door salesman Hakeem Thomas had knocked on her door attempting to sell some type of cleaner. [REDACTED] described Thomas as being a black male, in his 20's or 30's, thin build, clean shaven with short to medium hair. [REDACTED] said that Thomas was wearing light brown pants, shorts with white and red on them, a blue shirt, stripped tie, and a gray jacket. [REDACTED] also told me he was carrying a black backpack.

[REDACTED] advised that the Thomas entered her home to demonstrate the cleaner. First he demonstrated it by cleaning a portion of the carpet in the living room. [REDACTED] said Thomas then led her into the kitchen where he used the fluid to clean a section of the stove. [REDACTED] stated that following this, she walked out of the kitchen and sat down in the living room. [REDACTED] said that Thomas followed her out into the living room, at which point he stood in front of her, pulled down his pants exposing his genitals, and pulled her head towards him and inserting his penis into her mouth. [REDACTED] stated that she told Thomas "no" several times and even gagged, but that he continued holding her head so that his penis stayed in her mouth.

[REDACTED] said after a period of time, Thomas (with his pants still pulled down), walked over to the front door and closed it. [REDACTED] said that Thomas then walked back over to her, put on a white condom, stood her up and pulled her pants down. [REDACTED] said that Thomas then turned her away from him and entered her rectum with his penis. [REDACTED] told me that while this was occurring, she told Thomas several times "no" and to stop. [REDACTED] said that she was unsure exactly how long this continued, but said that during the entire assault, Thomas did not say anything to her. [REDACTED] stated that when Thomas stopped, he pulled his pants up and left stating that he might return after 1600 hours. [REDACTED] explained that in their conversation prior to the assault, she had mentioned that her husband would have to be the one to purchase the cleaner from Thomas.

[REDACTED] told me that after Thomas left, he called her friend [REDACTED] and told him about the incident. [REDACTED] told me that [REDACTED]

was the one who called the police. [REDACTED] told me that at no time did Thomas threaten her or physically hit her and said that she doesn't think that she had any physical injuries on her body. [REDACTED] was introduced to forensic nurse Tara, who conducted the sexual assault examination.

At the hospital, I was introduced to [REDACTED] who had arrived with [REDACTED] husband, [REDACTED] and I went into a private waiting room where I spoke to him about the incident. [REDACTED] stated that he had received a voicemail from [REDACTED] at 1549. The voicemail, which I listened to was [REDACTED] requesting that [REDACTED] call her back as soon as he received the message. [REDACTED] stated that he called her back a short time later and spoke to [REDACTED] who sounded upset and was crying. [REDACTED] told me that [REDACTED] had said that a black male selling cleaning fluid door-to-door had exposed himself to her and tried to force her to give him oral sex. [REDACTED] also stated that [REDACTED] had said that the subject had attempted to insert his penis in her rectum. [REDACTED] said that [REDACTED] asked him to come over saying that she was scared because he had said he would be back at 1600 hours. [REDACTED] stated that he started towards [REDACTED] house and called dispatch to report the incident while en-route.

[REDACTED] told me that he had a concern that [REDACTED] may be making up the story because he had heard that she had reported being a victim of a sexual assault earlier this year in which the suspect was never charged. [REDACTED] said that I should speak with [REDACTED] husband as he would have more information about the incident.

After speaking with [REDACTED] I talked with [REDACTED] husband, [REDACTED] I inquired about the incident that [REDACTED] had mentioned. [REDACTED] stated that it was an incident that occurred in 2005 in which [REDACTED] had accused a male named [REDACTED] of raping her. [REDACTED] stated that the incident was investigated, but that [REDACTED] was never charged because he claimed it was consensual sex.

After completing my interviews, I met with Detectives Lawrence, Pratt, and Stiffler and briefed them on my findings. I was asked to check the alley between Bannock and Ada in the 900 and 1000 blocks, specifically the garbage cans and dumpsters for the condom Thomas stated he had discarded. I was unable to find anything related to this incident. The interviews with [REDACTED] and [REDACTED] were recorded and attached. Only the first portion of my interview with [REDACTED] was recorded due to my recorder malfunctioning. That is also attached.

On 02 June 2011 I assisted in the investigation of the rape of [REDACTED] Bannock Ave, Idaho Falls, Idaho. Detective Sergeant Grimes assigned me to process the crime scene, [REDACTED] Bannock Ave. I arrived there at 1735 hours and found several people standing on the sidewalk. I introduced myself to the group and learned that one of the group is [REDACTED] the sister of the victim. [REDACTED] told me that she had returned home [REDACTED] Bannock Ave. just as the Police were arriving at [REDACTED] residence, and that she had remained outside [REDACTED] home making sure that no one entered. I thanked [REDACTED] for her actions and informed her that I would be processing the home, and that I would contact her later as needed.

I captured digital images of the exterior, front and back of [REDACTED] Bannock Ave prior to entering the home via the front door which was closed but not locked. I also noted that the front screen door was damaged with approximately 40 % of the screen separated from the frame. The front door leads into the living room which leads to the adjacent kitchen. I captured images of the living room to memorialize how it appeared upon my arrival.

Officer Goodman had communicated to me via phone that the suspect had given [REDACTED] tissue to wipe her self with after the assault, and that [REDACTED] had placed the used tissue in a basket next to a chair in the living room. I observed a white laundry basket next to a brownish green chair in the living room and noted that there was a white crumpled paper tissue in the basket as well as numerous other items. I captured images of the basket and its contents including the tissue before I removed the tissue and placed it into an evidence bag which I labeled. I also observed that there was another white crumpled tissue on a multi colored plastic stand next to the chair in the living room. I captured images of this tissue before collecting it and placing it into an evidence sack which I labeled and then secured.

Detective Pratt had been dispatched to [REDACTED] Bannock to further process the crime scene. See his report for details on what he discovered and did.

After Detective Pratt arrived, I interviewed [REDACTED] and [REDACTED] are sisters and [REDACTED] lives at [REDACTED] Bannock Ave, two houses south of [REDACTED] told me that at approximately 1510 hours this date an adult black male rang her doorbell. He was trying to sell cleaning product(s) to her but she told him that she already had some from a previous purchase. She told me that the subject had a foreign accent and did not speak English well. [REDACTED] had to leave to get her children from school at 1515 hours so she told the subject that she needed to leave. As [REDACTED] was backing out of her driveway, she observed the same male subject standing on [REDACTED] front porch. She observed the subject hand a pamphlet through the screen door and then open the screen door with his left hand. [REDACTED] then saw the subject entering [REDACTED] home via the door.

[REDACTED] described the subject as an adult black male, tall and skinny. She stated that the subject had long skinny fingers, and that he had high fived her twice during their conversation. She further described the subject as having no facial hair but his coloring was darker along the jaw line. The subject was wearing a casual gray jacket, plaid shirt that was green and gray with a white back ground. He had a tie on that "matched" his shirt as it was gray colored. [REDACTED] did not notice the subject's shoes.

[REDACTED] stated that she did not observe any tattoos or piercings on the subject. Nor did she notice that he had any jewelry on.

When [REDACTED] returned home from picking up her children from school, she noted that she had missed a phone call from [REDACTED] [REDACTED] home phone showed that the missed call was at 1629 hours but the phone is two minutes behind actual time making the missed call at 1631 hours. [REDACTED] then phoned [REDACTED] who told [REDACTED] "the guy had come in trying to get her to buy something." [REDACTED] told [REDACTED] that she was assaulted. [REDACTED] said that "the guy came in and was trying to clean the kitchen floor and pushed her head against the wall, and put his dick in her mouth," according to [REDACTED] told [REDACTED] that she told him "no." [REDACTED] told [REDACTED] that "he pulled her pants down, and was playing in her pants." [REDACTED] said that "he was trying to put his dick in her, and that he had a condom," according to [REDACTED]

[REDACTED] stated that she did not ask questions of [REDACTED] as the Police was arriving at that time.

The collected tissues have been air dried in the City of Idaho Falls Police Departments lab prior to being packaged for evidence.

The images that I and Detective Pratt captured while at [REDACTED] Bannock Ave have been backed up onto a CD and placed into property as evidence.

SUMMARY:

On 06/02/11 at about 1500 hrs., Hakeem Z. Thomas was walking door to door selling cleaning products in the area of Bannock street. Thomas contacted [REDACTED] at her residence of [REDACTED] Bannock. Thomas forced [REDACTED] to perform oral sex on him and then had vaginal intercourse with [REDACTED]. Thomas was found hiding in a van, had changed his clothing to alter his appearance and gave a false name to Ofc. Ockerman to prevent detection.

[REDACTED] is Developmentally Delayed and did not give consent for any sexual contact and even tried to pull away from Thomas as her resistance, but Thomas overcame this effort by force.

Thomas admitted to oral sex and vaginal intercourse with [REDACTED] but claimed this was consensual and that [REDACTED] had physically came onto him first. Thomas had originally lied about any vaginal intercourse or wearing a condom, but then admitted to this behavior after further questioning.

Originally Thomas had no reason for giving a false name, but then Thomas claimed to have been hiding because of a possible warrant out of Pocatello due to a citation that he had received. I found no record of any contact with Thomas in Pocatello, Chubbock, Blackfoot, Bingham or Bannock County. Thomas had also disposed of his used condom at a unknown location away from [REDACTED] residence.

Hakeem Z. Thomas was arrested and booked for RAPE, 18-6101

DET. STIFFLER'S REPORT:

On 06/02/11 at about 1620 hrs, I was advised there was a possible rape in the area of the 900 block of Bannock and the suspect may still be in the area. While enroute, I heard the suspect may be detained in the 900 block of Ada. On arrival, I observed several officers already on scene and several black males being detained. I was advised that a female that lives at [REDACTED] Bannock, reported that a black male was at her residence demonstrating a cleaning product and that he then sexually assaulted her. I contacted Ofc. Goodman who was with the reporting party. I requested him to bring the female to our location for a possible identification.

I then contacted Ofc. Ockerman who advised talking with a male named Maurice who is in charge of the group. Ofc. Ockerman asked who was in the van and Maurice advised 4, but Ockerman only observed 3 males in the van. Ockerman then advised seeing another male in the rear of the van that seemed to be hiding. Ockerman advised the male gave him a false name at first of James Bryant. Ockerman advised that he was given permission to look in the van by Maurice. Ockerman found a backpack in the rear of the van. He asked whose it belonged to and the male that was hiding in the van said it was his. Ockerman was given permission to look in the bag and found an identification card for the business. The picture matched the subject, but the name was different. The identification was for Hakeem Thomas and the male had no reason for giving the false name. Ockerman then found a gray sweatshirt, a tie and a white iPod in Thomas' backpack. Thomas advised that these were his clothing. Ockerman then

found a tan pair of pants under the back seat, which also Thomas said were his. See Ofc. Ockerman's report for detail.

Ofc. Goodman brought [REDACTED] over to our location on Ada. Goodman advised that [REDACTED] reported a black male came to her residence trying to sell her some cleaner. The male cleaned a spot on her carpet and then in her kitchen. [REDACTED] was then sitting on her couch when the male asked if she was interested and how she was going to pay. [REDACTED] told the male that her husband was the one who would buy it, but he wouldn't be home until after 1600 hrs. [REDACTED] reported that the male then pulled down his pants, grabbed her by the hair and forced her to give him oral sex. [REDACTED] reported trying to stop him, but she was too afraid to fight him. [REDACTED] reported the male then put a condom on and had sex with her from behind. It was thought that [REDACTED] meant anal sex.

[REDACTED] was allowed to look at all of the males, but didn't seem positive of any of the males. [REDACTED] was then shown Thomas' pants which she identified along with the tie, jacket, shirt and white iPod that the male had. [REDACTED] was very upset and was crying. [REDACTED] was having a hard time keeping control of herself and you could see a lot of fear in her. When I would get too close to the door, [REDACTED] would jump back to get away from me. [REDACTED] appeared to be traumatized by the events.

Due to the totality of the circumstances, Hakeem Thomas was placed under arrest for Rape by Ofc. Goodman. Thomas was placed in a patrol vehicle and [REDACTED] was then taken to ERMIC for a Sexual Assault Examination.

I talked with Alonzo Hayes who was the driver for the van. This conversation was recorded. Hayes advised that he didn't know any of the males in the van, except Maurice who is a supervisor. Hayes did not remember where he picked up Thomas. Hayes advised that Thomas did change his clothing in the rear of the van, but he didn't know why Thomas changed his clothing. Hayes advised they were not done working and there was no reason for Thomas to change his clothing. When Hayes saw that Thomas had changed his clothing, he knew things were not going to be good.

I then contacted Andrew D. Kelly who was also in the van with Thomas. Kelly said that Thomas already had his clothing changed when Kelly got into the van, but Kelly did not know why Thomas had changed his clothing. Kelly had no other information for me. This interview was also recorded.

Thomas was taken to the Law Enforcement Building for an interview. Thomas was placed in the East interview room by Ofc. Ockerman.

After getting more information about the accusation, I contacted Thomas for the interview. This interview was video and audio recorded.

THOMAS INTERVIEW:

I identified myself to Thomas and asked him some identification questions. I then gave Thomas a Rights Waiver form for his Miranda Warnings. Thomas read the Waiver form aloud and signed the form. Thomas advised that he understood his rights. Thomas advised that he works for International Sales and has worked for them for about 5 weeks. After questioning Thomas, I asked what happened at that lady's house. Thomas knew exactly who I was talking about. Thomas advised he told her about the soap, and then did a demo outside and then a demo inside the house. Thomas said he did a carpet demo and a stove demo for [REDACTED]. Thomas said he asked how she wanted to pay and [REDACTED] said to talk with her husband and her husband comes home at 4. Thomas said [REDACTED] started touching him and then put her hands down his pants. I asked how she started and Thomas said she wanted him. Thomas said [REDACTED] then pulled his pants down and put his penis in her mouth. I asked what then and Thomas advised doing what any other man would do, he just let it happen.

Thomas said he had a strong feeling that this wasn't right, so he left. I asked if she only gave him oral sex and Thomas said yes. I asked if he ejaculated and Thomas said no and then that he didn't remember. I asked if Thomas had intercourse with [REDACTED] either vaginal or anal and he said that he didn't. I asked Thomas if [REDACTED] had asked him to have intercourse with her and Thomas said that [REDACTED] did. Thomas said it didn't seem right, so he left. Thomas said that he just started working again and was picked up on the last street, which is Lincoln. I asked if where he was going to work next and Thomas advised where ever they took him.

I asked why Thomas had changed his clothing and Thomas said that he thought he had a warrant. Thomas said he had got a ticket in Pocatello for not having a license to sell soap. I then recapped what Thomas told me and asked what [REDACTED] had said to him before she started touching him, but Thomas couldn't remember. Thomas said [REDACTED] started rubbing his chest and then just shoved her hand down his pants and started touching

his penis.

I asked when Thomas put the condom on and Thomas got very vague. It didn't seem that Thomas wanted to admit to putting the condom on, but then did say he put a condom on. I asked again if Thomas had intercourse with [REDACTED] but he again denied this. I asked when Thomas put the condom on and Thomas got very quiet and I had to tell him to speak up. Thomas said [REDACTED] was giving him oral sex, he had her stop, he put the condom on and then she finished. I asked where he put the condom, Thomas said in the trash, I asked where and Thomas said somewhere else. Thomas said he threw the condom away in somebody else's garbage.

I explained to Thomas that [REDACTED] was getting a sexual assault exam done to her and that it would tell me if he had intercourse with [REDACTED] or not. I told Thomas that I would find out the truth and Thomas then said that he had intercourse with [REDACTED]. Thomas advised [REDACTED] gave him oral sex, he then put a condom on, [REDACTED] gave him oral sex again and then he had intercourse with [REDACTED]. I asked if it was vaginal or anal, and Thomas said it was vaginal intercourse. Thomas then said he left and threw the condom away. Thomas said he thought this wasn't right because he was on the job. I asked if [REDACTED] ever told Thomas no and he denied this. I asked what he did then and Thomas said he left. I asked if he took the condom off before he left and Thomas said that he did take it off. Thomas said that he put the condom back in the wrapper and took it with him. I asked why he didn't just throw the condom away in the house; Thomas covered his mouth and said that he didn't want to be disrespectful. I asked to whom and Thomas said to [REDACTED] household.

I explained that [REDACTED] was reporting that he forced her to have sex with him. Thomas was quiet for a while and then just repeated himself from doing the demo's until [REDACTED] started rubbing him. Thomas denied forcing himself on [REDACTED] but said that he did have sex with her. I asked Thomas if he would submit to a Sexual Assault Exam to gather evidence and he said it would be alright. Thomas said that [REDACTED] fluids are on him. I then asked Thomas if he wanted to make a written statement about the events, but Thomas denied this.

I left for a while, but returned to talk with Thomas. I asked how long it was after he left [REDACTED] house, until he was picked up on Lincoln and Thomas said about 45 minutes. I asked if he demonstrated at any other houses and Thomas said a few. I asked if anyone would remember him being there and he thought some should. Thomas did not remember how many houses he did demos in after he left [REDACTED]. I asked where he got dropped off at and Thomas said the top (south) and was working north. I asked Thomas his social security number because we still were not sure of his identity. Thomas had no formal State identification on him and nothing could be found. Thomas gave me a social security number that matched the one on his work ID. I then asked about the location of the condom, but Thomas did not remember where he threw it away at. Thomas didn't remember if it was on the same block or on some other block. END OF INTERVIEW.

Ofc. Goodman then took Thomas to ERMIC for the evidential exam. I copied the interview to a CD. I then took all of the seized items that belonged to Thomas and placed them in the drying chamber in the LAB.

I contacted Pocatello dispatch to confirm what Thomas told me about getting a citation for selling products without a license. The dispatcher advised that she had no record of any contact with Thomas.

I then contacted Det. McDonald at [REDACTED] Bannock. I was advised [REDACTED] reported allowing Thomas in the residence to demonstrate some cleaning products. [REDACTED] stated Thomas cleaned a spot on the carpet and then the stove. While Thomas was cleaning the stove, [REDACTED] sat down on the couch. When Thomas discussed the price, [REDACTED] told Thomas that he would have to talk with her husband, but he gets home at 4pm. [REDACTED] advised that Thomas was standing in front of her while she was sitting on the couch. [REDACTED] advised Thomas then pulled down his pants, grabbed her by the back of the head and forced her to perform oral sex on him. [REDACTED] said she told him no, but he continued. [REDACTED] said that Thomas stopped, closed the front door which was still open and then returned to her. [REDACTED] reported that Thomas then put on a condom, turned her around and had sex with her, from behind. When Thomas finished, he gave her a tissue and had her clean off and then left the residence.

We searched the area for the used condom, in every trashcan and dumpster in the immediate area, but did not find it. I contacted several residences, but only one advised a male trying to sell them cleaning supplies. The male left the residence and traveled south bound, which would have been going toward [REDACTED] house.

I later was contacted by Ofc. Goodman who brought the seized evidence, from the hospital, to the LEB. Ofc. Goodman advised the Safe Nurse reported that there was bruising in [REDACTED] mouth and what looked like a piece of condom found inside [REDACTED] vagina.

All evidence was placed in the LAB overnight.

On 06/03/11 at about 1130 hrs, I contacted Tara Demkowicz who was the nurse performing the Sexual assault exam. Demkowicz advised there was bruising around [REDACTED] mouth which could indicate forced oral sex. Demkowicz also advised of the piece of condom that was located in [REDACTED] vagina. Demkowicz advised that there was no trauma to [REDACTED] anus. Demkowicz advised that [REDACTED] was very meek and mild mannered, she also thought [REDACTED] was mentally slow. Demkowicz advised that [REDACTED] could not remember the last time she had intercourse with her husband and didn't appear to be sexually active.

I placed all property into evidence.

[REDACTED] INTERVIEW:

On 06/06/11 I contacted [REDACTED] at her Guardian's residence. [REDACTED] guardian is [REDACTED] who is her sister in law. [REDACTED] was described as being Developmentally Delayed and Bi-Polar, by [REDACTED]

I asked [REDACTED] to tell me when she first met Thomas. [REDACTED] said she was sitting on her couch when Thomas knocked on her screen door. [REDACTED] advised Thomas showed her a pamphlet about the cleaning products. [REDACTED] advised that Thomas walked into the residence with out being asked in. [REDACTED] advised that Thomas then demonstrated the cleaning product on the carpet. [REDACTED] also advised that Thomas started dancing while doing the cleaning demo and had asked [REDACTED] if she liked the way he danced. [REDACTED] was confused about this and then they went into the kitchen where Thomas demonstrated the cleaner on the stove. They then came back into the living room and [REDACTED] said she sat on the couch. I asked what they were talking about when they walked into the living room. [REDACTED] advised Thomas asked to stay and [REDACTED] said no. [REDACTED] said Thomas wanted to show her husband the cleaner, but she told Thomas he couldn't stay. Thomas then pulled down his pants and pulled out his "thing" which was Thomas' penis. [REDACTED] said she was still sitting on the chair. I asked [REDACTED] if she ever had shook Thomas' hand or touched his arm or shoulder. [REDACTED] said that she never touched Thomas before Thomas pulled out his penis. [REDACTED] said she never complimented Thomas or talked in a flirtatious manner to him. I asked if Thomas complimented her and [REDACTED] said she did not remember Thomas saying anything. [REDACTED] said that Thomas then pulled out his penis, put his hand on her head and pushed her head to his penis. [REDACTED] said Thomas never said anything when he pulled his penis out. [REDACTED] said Thomas put her head to his penis and put his "dick" in her mouth. I asked what she did at this time and [REDACTED] said she was backing away from Thomas. When [REDACTED] kept backing away and Thomas kept pushing her head up against him. I asked [REDACTED] if she ever tried to push Thomas away and [REDACTED] said no, that she never tried to push Thomas away because she was afraid Thomas would hurt her. [REDACTED] did say she was trying to pull away to get Thomas' hand off her head and his penis out of her mouth, but it didn't work. [REDACTED] said she was gagging and choking. I asked if [REDACTED] was forcefully trying to pull away or gently pulling away and [REDACTED] said she was forcefully trying to pull away, but Thomas kept pushing her head to his penis. I asked if she couldn't out power Thomas and [REDACTED] said Thomas was too strong for her.

I asked [REDACTED] what happened next and she advised Thomas put his hand in his pants and touched her breast. [REDACTED] said that she didn't like this. [REDACTED] said Thomas took her by the hand, stood her up and pulled her pants and underwear down. Thomas then put a condom on and said he "stuck it in the back behind me". I asked [REDACTED] if she tried to get away when he turned her around and [REDACTED] said no because she knew Thomas would do something to her. [REDACTED] said she didn't want to fight him because he was strong. [REDACTED] said she wanted to reach back and kick him, but she didn't. [REDACTED] said she didn't kick Thomas because she didn't want to get in trouble. I told [REDACTED] that she could defend herself if anyone tried to hurt her and she said OK. This seemed to be new information to [REDACTED] and really appears that she didn't know she was allowed to defend herself.

I had [REDACTED] tell me again the order of what happened. I then asked [REDACTED] exactly where Thomas put his penis and [REDACTED] said her "bottom end". [REDACTED] said she was sure and that Thomas never put his penis in the front end. [REDACTED] said Thomas was behind her, but maintained that Thomas put his penis in her rear end. [REDACTED] said she knows Thomas put his penis in her bottom end because she felt it. I asked where she was standing when this happened and [REDACTED] said her arms were on the couch and chair. I asked [REDACTED] what her "front" was and after some thought, she said vagina. [REDACTED] said the front was the vagina and the rear was the bottom end. [REDACTED] was again certain that Thomas put his penis in her bottom end. I asked what happened next. [REDACTED] said after Thomas "came" in the condom, he took it out (his penis) and pulled up his pants. Thomas then went to the kitchen, got some toilet paper, rolled up his condom and put it in the toilet paper. Thomas also gave her a piece of toilet paper to clean off. I asked [REDACTED] what Thomas did with the condom and she thought Thomas either put it in his jacket or threw it in the trash. I asked what happened next and [REDACTED] said that Thomas left the house. Thomas then said to [REDACTED] that he was going to come back at 4 o'clock but he never did. [REDACTED] said she was afraid that Thomas would come back so she called a friend. [REDACTED] said she called her sister, but she never would answer, so she called a friend and he called the police.

I asked when Thomas first came to her house and [REDACTED] said after 3 o'clock(1500 hrs). [REDACTED] said Thomas's demonstrations didn't last very long and that he was at the house for about 30 minutes. [REDACTED] thought Thomas left about 1530 hrs. I asked [REDACTED] what Thomas was saying while he was there and [REDACTED] said that she couldn't hear what he was saying because he spoke so quietly. [REDACTED] did say that Thomas told her that he was from California. Thomas told her this when they were in the kitchen. [REDACTED] also said that Thomas told her his favorite color was purple and that Thomas said this when he was cleaning the carpet. [REDACTED] did not know why Thomas told her this. [REDACTED] just guessed that Thomas wanted her to know what his favorite color was. [REDACTED] thought it was a good job when Thomas showed her how clean it got the stove. [REDACTED] again said that Thomas asked if he could stay, but she said no. I asked if Thomas ever made any threats to her and she said not that she can remember.

I asked who [REDACTED] PSR worker was and [REDACTED] said Audra. I asked why she had a PSR worker, to which [REDACTED] said Audra takes her for walks and helps her with stuff like shopping and makes sure the house was clean.

I then asked [REDACTED] to tell me about the incident at her residence, between her and Thomas, but to tell me the same story in reverse. My reason was to verify her story and to see if she could remember any other details. [REDACTED] could tell me the story with the same accuracy as the first time she told me. I asked [REDACTED] why she comes over to [REDACTED] house and [REDACTED] said it is because [REDACTED] thinks of hurting herself. I asked if she needed to tell me anything else and [REDACTED] said she needs to tell her therapist that she is afraid of guys. I asked if she was afraid before the incident with Thomas and she said she wasn't afraid before then. I asked if she is afraid of her husband and [REDACTED] said she was now. [REDACTED] didn't know if he would hurt her. [REDACTED] said that she was afraid in her own house yesterday because she thought Thomas would come back. [REDACTED] also said she was having nightmares about this. I then told [REDACTED] that she could push someone away from her if they are trying to hurt her and [REDACTED] said she didn't know that before.

I asked again if Thomas had introduced himself to her when Thomas came in the house and [REDACTED] said he didn't. I asked [REDACTED] if she ever shook Thomas' hand at any time and [REDACTED] said she didn't. I asked [REDACTED] when she sat on the couch and before Thomas pulled out his penis, if she shook Thomas' hand or touched Thomas at all and [REDACTED] said that she never touched him. [REDACTED] said she was so scared and was sitting there scared.

I then took [REDACTED] written statement that had been given to her earlier.

I talked with [REDACTED] who advised of [REDACTED] diagnosis. [REDACTED] directed me to Cindy Adamson at Mental Wellness. [REDACTED] said that she was Developmentally Delayed and that she has Bi-Polar. I then asked how [REDACTED] reacts due to her Bi-Polar and how her personality changes. I asked [REDACTED] how she reacts when someone tells her to do something that she doesn't want to do. [REDACTED] said that she tries to hurt herself, but doesn't try to hurt anyone else. [REDACTED] says she tries to hurt herself then or when she is by herself. I then asked [REDACTED] what she does when she is scared. [REDACTED] says she backs away. [REDACTED] said that she never hits or attacks when she is afraid, but tries to get away.

Later, I placed the Sexual Assault Exam results and photographs into evidence. In the same evidence folder, I placed Thomas' Rights Waiver and [REDACTED] written statements. I also copied all audio interviews to a CD and placed them into evidence. I also placed Thomas' Interview into

I then contacted Pocatello PD, Bannock County, Blackfoot/Bingham County and Chubbock concerning Thomas saying that he received a citation for selling products with out a license. None of these departments had any record of any citations being issued for Thomas or even a contact with him.

06/10/11 FOLLOW UP:

On 06/10/11 at about 1035 hrs. I received a fax from Mental Wellness Centers that showed a report dissscharge summary for [REDACTED] that notes her mental IQ was 58.

06/14/11 FOLLOW UP:

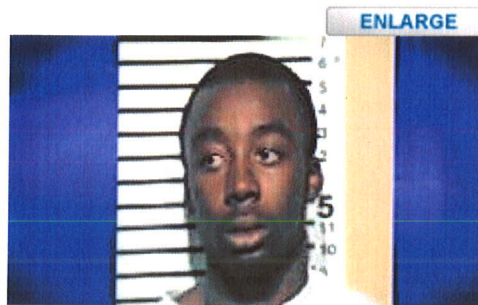
On this date, Thomas' wallet and white Ipod was released to his mother. I photographed this property before it was released to her. I also received a fax from Cindy Adamson that pertained to [REDACTED] mental assessment. This test was taken on 08/28/08. This test showed the results of the psychological testing of [REDACTED] and this indicated a score of 58. The bottom notes indicated a diagnosis of Mild Mental Retardation and Vascular Dementia. I will attach this to the report.

IDAHO FALLS, Idaho -- A door-to-door salesman was sentenced to 10 years in prison for beating and trying to rape an Idaho Falls woman.

Judge Dane Watkins Jr. said 18-year-old Akeem Thomas must serve at least three years before he will be eligible for parole. Bonneville County Chief Deputy Prosecutor Daniel Clark said Thomas, of Oakland, Calif., was going door-to-door selling cleaning products when the assault occurred.

The victim in the case said Thomas entered her home to demonstrate his cleaning products, and [after the demonstration took off his pants and raped her](#). Police said after Thomas left the home, the woman called a friend who called police.
