2 Partial Transcript of 10-19-07 Jury Trial - Excerpted
3 portion of the testimony of Britney Langlois.

5 BRITNEY LANGLOIS

6 called as a witness, having been first duly
7 sworn, was examined and testified as follows:

8 THE COURT: Would you please come around and
9 have a seat in the brown chair. And the microphone
10 can be moved so you're comfortable

11 DIRECT EXAMINATION BY MR. SCHWARTZ

12 Q Britney, could you state your first and last name for
13 the court reporter, and could you spell them both for
14 the court reporter.

15 A My name is Britney Langlois, B-r-i-t-n-e-y, Langlois,
16 L-a-n-g-l-o-i-s

17 Q Okay. Britney, I'm going to ask you some questions
18 about November 21, 2006. You remember that date
19 don't you?

20 A Yes.

21 Q What I want to do is talk about what you remember
22 about that date from the beginning of the day. So
23 what's your first recollection of November 21st? What
24 were you doing? Where were you?

25 A I was at my mom's house. Um, I had just came back up

1 here from Baton Rouge and Arlington, Texas and came up
2 here to spend Thanksgiving with my mom.

3 THE COURT: Could you slide the microphone a
4 little closer to you. Thank you.

5 BY MR. SCHWARTZ:

6 Q Your mom would be Shannan Preston?

A Yes

8 Q Okay. And you mentioned that you were down in Baton
9 Rouge and Arlington, Texas?

10 A Yes.

11 Q What were you doing down there?

12 A I was selling magazines.

13 Q You had a job?

14 A Yeah.

15 Q How is it that you went down to Baton Rouge and
16 Arlington, Texas?

17 A Um actually, it's like advertising for people to sell
18 magazines and if they want to gain more public
19 speaking skills, and I went down there to take on the
20 offer

21 Q Okay It's a little curious that you go from Madison
22 down there. Who arranged that for you?

23 A Oh, actually, um, Trinity Public Relations. That's
24 the organization I was working with

25 Q And they had an office in Madison someplace?

1 A Oh, no. It's advertisements. Like when I went to the
2 library, um, I seen it in the advertising section in
3 the library. They based in Charlotte, North Carolina,
4 but, um, at that time, they were down in Arlington
5 Texas, and then we moved to Baton Rouge.

6 Q Okay. How long were you down in Baton Rouge and
 Arlington, Texas?

8 A I was in Arlington about two and a half months and in
9 Baton Rouge about a little over a month and a half.

10 Q Which one were you at last?

11 A Baton Rouge.

12 Q Okay. You say you were down there for about four
13 months or so, right?

14 A Yeah.

15 Q Had you come back to Madison a all during that time?

16 A No.

17 Q So when you came back to Madison for Thanksgiving with
18 your mom, that was the first ime you had been back in
19 about four months?

20 A Right.

21 Q And during the time that you were down there, you were
22 selling magazines?

23 A Yes

24 Q How did that go?

25 A Um, it went good, actually.

1 Q Okay. What do you mean it went good?

2 A Um, it was nice, um --

3 Q Well, were you successful at it?

4 A Oh, yeah

5 Q Okay. Define what you mean by "successful.

6 A Um

7 MR. BLANCHARD: Objection, Judge; relevance

8 THE COURT: Overruled. Go ahead.

9 A I was able to, um, sell my product and, you know, I

10 like talking to people, so I was able -- I was able to

11 talk to people and, you know, sell magazines.

12 Q Okay. And you got money from this, right?

13 All right. Now, do you remember about what date

14 it was that you came back up to Madison to be with

15 your mom at Thanksgiving?

16 A Like four days before

17 Q Four days before Thanksgiving?

18 A Yeah.

19 Q When you returned --

20 A No, like four days before this whole incident

21 Q Okay. All right. So four days before November 21st?

22 A Yeah.

23 Q All right. Now, when you, um, came back up from Baton

24 Rouge and Arlington, Texas, did you have money?

25 A Yeah.


